#### About the Asian Composers League (ACL)

The ACL was established in 1973 by leading composers from Taiwan, Japan, Hong Kong and Korea, and is now one of the most vibrant and active communities of composers in the Asia-Pacific region. There are currently more than fifteen Full Members (see the ACL website for a full list of members: [www.asiancomposersleague.org](http://www.asiancomposersleague.org)). The objectives of the League are:

- To promote, preserve, and develop the musical cultures of the Asia-Pacific region, particularly in the field of music composition; *and*
- To further interests of composers in the Asia-Pacific region through representation and negotiation, and to achieve recognition of their rights in national and international law.

The ACL Conference-Festivals are magnificent events held on average every 18 months, and are hosted by Full Members under the auspices of the ACL. It is an important vehicle for Asian-Pacific composers to present their works, exchange ideas and build solidarity.

#### Membership information, rights & privileges

We welcome applications from individuals to become Individual Members of the ACL. Individual Members have the following rights and privileges:

Individual Members...

- ...may submit up to two (2) works of different categories to ACL Festivals
- ...are not guaranteed performance of any submitted work
- ...do not pay an entry fee for submitting works
- ...may take part in official deliberations
- ...do not have Voting Rights at the General Assembly
- ...may not be members of the Executive Committee
- ...may not submit a work for the Young Composers Competition
- ...must pay their own accommodation costs at Festivals



## Application process

Your application will be considered at the next meeting of the ACL Executive Committee (see below). Upon receipt of the individual's application, the Secretary will forward it to members of the ACL Executive Committee for consideration. Final acceptance/verification of membership will take place at the following meeting of the Executive Committee. Once accepted your details will appear on the ACL website.

## Fees

After final acceptance of the Individual Membership, the Treasurer will invoice the individual for the membership fee. Membership fees are due annually.
